Rules & Regulations

The following constitute the Rules and Regulations of Lawrence Plantation, (the "Club"). These Rules and Regulations may be altered, amended and modified at any time. All Members of the Club and their respective family members and guests shall abide by and comply with all of the following Rules and Regulations.

Please read these Rules, as well as the Membership Agreement carefully, sign where indicated, and return to the Club at pool registration or the address listed: LAWRENCE PLANTATION AT HORSELEG CREEK, 127 Winding Road, Rome, GA 30165.

POOL RULES

1. Only Members and their accompanied guests may be admitted. Members and their guests must sign in at the front gate. The number of family members and their guests allowed at the Pool at any given time is limited to six (6) per family, unless previous arrangements have been made with the Pool management. Each Family membership includes five (5) FREE GUEST PASSES per Pool season. Once free passes are used, additional Guest passes are \$5.00 per guest and are payable when signing in. Members will be responsible for all liability for guests brought to the pool. A family consists of up to six (6) family members living in the same household.
2. All persons shall obey the instruction of the lifeguards. No person is permitted to use the pool unless it is open and a lifeguard is on duty in the lifeguard chair.
3. Talking to the on-duty lifeguard in the lifeguard chair is not permitted.
4. Any accidents, including vomiting and defecating in the pool, must be reported to the lifeguard immediately.
5. In the event of bad weather, the pool may be closed until it is deemed safe to return to the water.
6. In an emergency, the pools must be cleared immediately.
7. Persons unable to demonstrate to the lifeguard their ability to swim are not permitted in water deeper than three feet.
8. Lifeguards may suspend, for a period not to exceed seventy-two (72) hours, the right of any person to remain at or use the pool if the lifeguard concludes that the person is in violation of the Pool Rules, disobeys lifeguard's instructions, uses abusive language, appears to be intoxicated, and/or conducts in a way that threatens the safety and/or well-being of any person or the property. Subsequent to expulsion, any person may appeal the decision to Management of Lawrence Plantation at Horseleg Creek.
9. All applicable membership dues and fees must be paid before use of the Pool. Dues and fees cannot be prorated.
10. Use of the pool facilities at the Club at any time is at the swimmer's own risk.
11. Lawrence Plantation at Horseleg Creek and its management cannot be held responsible for any lost or stolen items, or items left at the pool.
12. Swimming is permitted only during open hours of the pool.

13. The Bathhouse is open only during Pool hours of operation. Loitering in or around the Bathhouse area is prohibited.
14. Children under 14 years of age are permitted to use the pool facilities only if accompanied and supervised by an adult 18 years of age or older. No more than five (5) persons under the age of 14 may be supervised by an adult 18 years of age or older.
15. All members are required to familiarize their children and guests of all pool rules. Parents are responsible for their children whether the parent is at the Pool or not.
16. Showers are required prior to entering the pool.
17. Glass objects, drinking glasses, sharp objects, gum, food and tobacco products are not permitted in the pool area.
18. No intoxicants, including but not limited to alcoholic beverages, are allowed on or within the pool area. Intoxicated persons are not allowed to remain in the pool area at any time.
19. All swimmers must wear bona fide swimming attire. Cut-offs, dungarees, thongs and bermuda shorts are not considered appropriate swimwear and are not allowed.
20. Children 3 years of age and younger, as well as any child not potty trained, must wear snug fitting plastic pants or a water resistant swim diaper.
21. Admission may be refused to anyone with skin abrasions, colds, coughs, extremely inflamed eyes, infections, or wearing bandages.
22. Expectorating (spitting) and blowing of the nose in the Pool is prohibited.
23. The following activities are strictly prohibited: Running, pushing, diving, dunking, ball playing, the throwing of frisbees or wet clothes, noisy or hazardous activity, dangerous games, etc. Pool Management and lifeguards have the authority to disallow any exuberant play that may interfere with the enjoyment of the Pool by others.
24. Radios may only be used at low volume or with earphones.
25. All persons using the pool furniture are required to cover the furniture with a towel when using suntan lotions.
26. All persons using the pool area are urged to cooperate in keeping the area clean by properly disposing of towels, cans, trash, etc.
27. Saving chairs for persons absent from the pool area is not permitted.
28. Private parties may be held in the pool area only with a reservation and completed rental agreement approved by the Club Manager.
29. No play equipment, play pens or wheeled vehicles (except wheelchairs and infant strollers) are allowed in the Pool area. Flotation devices are permitted for non-swimming children up to the age of five years. Any non-swimming children must be accompanied in the water by their parent or adult guardian. Pool toys such as balls, water guns, rings, etc., are permitted at the discretion of the lifeguard and/or Club Manager dependent on the number of people in the pool and the manner in which the toys are used. Tire inner tubes are not permitted.
30. Only children under the age of three (3) may utilize the baby pool.
31. No pets are allowed in the Pool area or on Pool property (except service animals).
32. Smoking is prohibited on any of the Club property.
33. Food and Beverages provided by the Club are allowed in the pool area. Food and beverage is not allowed to be brought in 'from home' or from other food service establishments. Exceptions can be made for special diets and/or infants.
34. Subjects not covered by these Rules will be handled by lifeguards on duty or Club Management.
35. Club Management is empowered to interpret and enforce these Rules.

TENNIS RULES

1. The rules of tennis of the U.S.T.A. and its Code of Conduct shall apply at all times, except when in conflict with the local rules or with any of the rules herein.
2. At the end of their playing period, players must promptly relinquish their court to the next players
3. Proper tennis attire is required at all times. Colors are permitted. Regulation tennis shoes are required.
4. Proper tennis etiquette should be observed at all times. Excessive noise, racquet throwing or profanity will not be permitted on the courts, or in the area of the courts, at any time.
5. **Non-Member Guest Policy**
Members are required to pay the guest fee before play begins. No guests are allowed to use the tennis facility unless they are accompanied by a member or prior arrangements have been made with the head pro. Non-members may sign up for programs and camps at the non-member rate.
6. **Court Reservation Policy**
Reservations may be made on outdoor and indoor courts up to seven (7) days in advance. Courts may be reserved for a playing session of one and a half hours (1 1/2) outdoors and one (1) hour indoors. Teaching programs will have precedence on the indoor courts during inclement weather. Actual play will have preference over usage of practice hitting wall court assuming all other courts are in use. Court reservations should be canceled at least 24 hours in advance and reservations are canceled for no-shows after 10 minutes when the courts are in demand. Open courts are available without reservations, first-come, first-served.

GENERAL CLUB RULES

1. Animals and pets are not allowed on or within the Clubhouse or within the pool or tennis areas of the Club; provided, however, seeing-eye dogs may accompany those Members or properly introduced guests who are in need of such special assistance.
2. Vehicles left unattended on any of the Club property after closing are subject to being towed at the expense of the owner thereof.
3. All Members will be held responsible for the conduct of their guests, their children and their children's guests while on Club property and for their adherence to all of the Rules and Regulations of the Club. Each Member shall be responsible and reimburse the Club or third parties for any damage to the Club property or to the property of others caused by such Member's guests, the Member's children or their children's guests. Members may be disciplined for any violation of these Rules and Regulations by their children or guests.
4. The Club Manager shall have the right to require any Member and his or her guests to leave the Club property due to conduct which, in the opinion of such Club Manager, is unbecoming or disorderly.
5. Controlled Substances (as defined by state and federal laws), other than those prescribed by a physician for medical reasons, are not permitted on the Club property.
6. The Club management may enact dress codes mandating and/or prohibiting certain types of dress within all or certain portions of the Club.
7. Firearms and ammunition are not permitted in the Clubhouse or anywhere else on Club property.
8. The facilities of the Club are for the exclusive use, accommodation and enjoyment of the Members of the Club and their invited guests. Guests of a Member may be entertained at the Club only when accompanied by the Member who invited such guest. The conduct and behavior of guests are the responsibility of the Member host. A Member shall not introduce as a guest any person who has been suspended or expelled from the Club unless such person has been reinstated or his record is so clear so as to make him eligible for reinstatement. Unescorted guests shall not be left at the pool, tennis courts or on Club property.

9. Neither the Club, its directors, officers, employees or contractors, shall be liable for any injuries to person or damage to or loss of property involving Members, guests or other persons on the Club premises. Each Member agrees to indemnify and hold Club, its officers and employees harmless from and against any and all claims made by their guests or invitees as a result of any personal injury, damage to or loss of property occurring on the Club premises not proximately caused by the gross negligence or willful or wanton conduct of the Club's employees.
10. A Member desiring to give a private party shall complete a rental contract with the Club Manager and, if required, shall post a security deposit in such amount as may be required by the Club Manager. Club Members receive a 15% discount on published rates for use of event facilities.
11. Club property removed, damaged or destroyed by a Member or Member's guest will be charged to such Member. The Club is not responsible for any private property belonging to a Member, any Member's children or any Member's guests.
12. Smoking is prohibited on all of the Club property.
